CLOSED SESSION – PURSUANT TO VIRGINIA CODE SECTION 2.2-3711(A1, A3, A5, A7)

Upon motion by Mr. Hutchins, seconded by Mr. Hendrick, and passing, the Board convened a Closed Session for the discussion of personnel, legal matter, as authorized by Virginia Code Section 2.2-3711(A1, A3, A5, A7).

Mr. Cornwell explained the purpose for entering Closed Session as listed below.

- 1. Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body; and evaluation of performance of departments or schools of public institutions of higher education where such evaluation will necessarily involve discussion of the performance of specific individuals. Any teacher shall be permitted to be present during a closed meeting in which there is a discussion or consideration of a disciplinary matter that involves the teacher and some student and the student involved in the matter is present, provided the teacher makes a written request to be present to the presiding officer of the appropriate board.
- 3. Discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body.
- 5. Discussion concerning a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community.
- 7. Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the public body; and consultation with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel. For the purposes of this subdivision, "probable litigation" means litigation that has been specifically threatened or on which the public body or its legal counsel has a reasonable basis to believe will be commenced by or against a known party. Nothing in this subdivision shall be construed to permit the closure of a meeting merely because an attorney representing the public body is in attendance or is consulted on a matter.

Mr. McCraw told that everyone may disagree with what he is getting ready to say but he feels like under the circumstances, the best thing they can do as a Board is to take this opportunity to think about this, talk with constituents and find out how they feel about this issue. He told that we need to do what the majority of our constituents wants. He told that we should take this under advisement until a later date.

CITIZENS TIME

Traphena Horsley told that it is not an issue at the moment but she feels like the Country is getting out of hand on the Confederate issue. She told that the people that were shot were Christians regardless and the young man that waved the flag didn't take it there. She told that you are always going to have racists but the flag doesn't mean racism

to her. She told that to her it means a way of life that we have here in the South. She told that there was a man who said, this is how we riot in the South. She told that no one wants black people or Mexicans in chains and quite frankly anymore she feels like we are all slaves to our government because our freedoms are disappearing. She told that you have to draw a line somewhere and the ISIS people are waving our flags and how long will it be before we can't use the American flag.

Jerry Cooper told that he agrees with what they said so he has nothing else to say tonight.

Andy Jackson told that he hopes everybody realizes the flag has never killed anybody and it has had alot of good men die for it. He told that it is a sacred thing for the military. He told that 10 years ago we went through this and everything they were doing got misconstrued. He told that most people in this County is going to agree with him. He told that where it is an issue is where they fly it 24 hours a day and we don't do that here. He told that we use it for historic events. He told that the American flag was not allowed to be flown anywhere besides a federal building before 1941. He thanked the Board for taking an honest look at this.

Edith White told that she is impressed by the emblem on the wall. She told that on the flag issue it is like an object being attacked when the flag had nothing to do with it. She told that she hasn't encountered anyone who has hate like that. She told that it is our heritage and if we forfeit our rights. She told that there are two sides of it and she thinks the guy who done it was mentally ill and they are doing it to make people feel better. She told that we shouldn't be convicted over something that we had nothing to do with it. She told that her dad was in World War II and he didn't choose to do it.

Sue Orr told that she is very passionate about her family history and much of that is tied up in Carroll County. She told that it is very important that we remember our history. She told that she would like to remember her ancestors who responded to the call. She told that if this flag comes down what is next, will the statue that honors them be next. She told that the general public you are going to find out that our heritage will outweigh.

Bonnie Reeves told that she is President of the Jefferson Baptist Chapter so you can guess where she stands on the flags. She told that the first National flag flew over Lees headquarters, not the battle flag and people don't realize the different flags. She told that never was the battle flag the official Confederate flag. She told that when we let the flag go we let our history go. She told that the children are not being taught the history as it is.

Myrtle Bryant told that she is standing for this flag because she has a great, great grandfather that fought for this flag and she is proud of it. She told that the flag has nothing to do with what is going on and she would appreciate if we would keep it up. She told that she would like for her grandchildren to know their relatives.

ROOFTOP PRESENTATION

Mr. Hutchins told that he is Chairman for the Rooftop CAP and they celebrated the 50th year celebration in May and he would like to present a plaque representing what Carroll has done. He told that a lot of folks don't realize the support for the region that comes from Rooftop but it starts with Early Head start, weatherization, indoor plumbing and so on. He told that without the support of localities they would not be able to do it.

He told that as far as the selection for the IDA, he does not know the man that we voted on but he read the paragraph that he put in and he seems real qualified so he has no problem with the way it turned out. He told that we got some good applicants and he is a personal friend of Mr. Hurst and I know what he knows what he does so he was voting for what he knew. He told that it wasn't a vote against him.

Mr. McCraw told that he appreciates everyone coming tonight and expressing their thoughts in a Carroll County way, it makes him proud. He told that it is not a non-issue, they want to hear what the people have to say before they make a decision. He told that he would like to invite everyone to come back.
